You ordered sending data when obtained re handling in relation to SPT Update report of April 7th.

The SPT update report of April 7th informed us that St Pete Time's reporter Bette Orsini has been tracking down the sources of documents regarding the Easter Seal Society of Pinellas County. Her investigation had been into the IRS area regarding certain documents that were apparently gotten at one time having to do with the Easter Seals society. Bette apparently followed down the name of the person who made the info requests from the IRS, and began working with a private detective (John Turner of Seminole, Fla) whom Bob Andringa, SPT Attorney, hired.

It could be rumored that the private eye and/or Orsini plan on locating and then deposing the person they are after. This person that they are interested is R.W. Martin whose name is on the IRS form for the request for materials. From this info she has been traced down to her Clearwater address most likely and questioning done the investigation came to a stop. The two working together, Orsini and Turner, continued apparently and got comm with R.W.'s relatives on 15 April (her great aunt, grandmother and brother) asking for the whereabouts of R.W. They had come to a stop in their local effort in Clearwater as apparently there is no lead from there.

From what I heard, none of the relatives cooperated with information about her whereabouts or about her past experiences, though this is not definite totally with the grandmother and great aunt. But they wouldn't have R.W.'s present whereabouts.

Since this time nothing on this effort by Orsini or Turner has been heard of. Nothing with the relatives has been done either. It appears that they have failed to come up with anything solid in their investigation.

The intention on their part and what might be considered a liability on our part is that they are trying to locate and deposition R.W. If they could do this they could determine that she is the same person that obtained the IRS material regarding the Easter Seal Society and that she is a Scientologist. This they would most likely appreciate using in their suit which the SPT presently has against the Church and most probably in some press pieces to the effect of alleging dirty work or some such nonsense. Though untrue, either one is undesirable for us especially any added fuel to the lawsuit.

RW has most probably been located and is being handled, of that I am sure. The following has been determined thus far:

1. Relatives have been spoken to and handled with drilling, R factor, etc not to be speaking to inquisitive strangers.
2. Relatives spoken to and just what was said is being determined.
3. Possible connections of interest are being fully determined and covered so as to cut all comm lines; some are individual being handled or disinformed as appropriate with only one comm line maintained for handling purposes.
4. R.W. is moving to an unknown location. She is being made inaccessible.

One to three above are nearly done with 4 to be done so Secure comm lines between Base and her current location have been established so fast relay of vital info can occur as needed.

So that is the PT data and you will be kept informed.

Dear Mary Sue,

You wanted to know the scene on the blown agent's at Base and if it was the same person used in Easter Seal (Op) as was used at the CW Sun and in the AMA.

Basically the scene is that we had two agents one in the CW Sun and one in the CW Chamber of Commerce. The Chamber of Commerce agent was used in the Easter SEals operation, not the CW Sun agent but the clincher is that both of these agents were in the AMA and had previously been blown.

The liabilities of this are that it would be feasible for Orsini to be able to pull the strings on these agents back to the AMA and from there to the Coopers and Meisner. Considering the current sit with Meisner, this could be a bad situation for the Church and if not handled could potentially lead to an expanded Grand Jury investigation of the Church. I do not think it will come to this and feel that we have enough time and resources to handle.

Attached is a little estimate of the data and a proposed handling. Aside from the obvious security precautions, I feel that it is vital that we get some kind of feedback back in DC and onto Orsini as we have little inside data which makes the outpoints we do have seem a bit alarming at this time.

The handling is on the last two pages of the excerpted report.

INFO REPORT

Dear Joe,

Howard Wireback of the CW Sun knows the following and thus it is likely that it is well know at the Sun:

About 2 weeks ago Bette Orsini of the St. Pete Times called into the CW Sun asking about one of their employees. We understand that this was probably about some bones they had to pick or another. The CW Sun was very reluctant to give out any data on their bag of bones, but they understood that this was in relation to a [REDACTED] scene. Due to this, and the innate lack of accord between the Sun and the Times, all that Orsini was given was the telephone number of the ex-Sun editor, Al Hutchison in Massachusetts.

As a result of this comm, CW Sun reporter Steve Advokat got interested in the cycle and checked up on the [REDACTED] agent's [REDACTED] in the Sun. He realized that this must have been all false, but was left with the consideration that this had to do with the [REDACTED], based on his recollection of his [REDACTED] bag of bones.

From this:

PARTIAL PREDICTIONS:

1. That Orsini will contact Hutchison for more info on the above.
2. That [REDACTED] *legal people* of the Sun and Times will attempt to find bones for their use.
3. That Orsini may *investigate* [REDACTED] this into [REDACTED] *AMA's* area. (this would be via ss number)
4. That either or both of the papers may run with this in the press, but it is likely that they would do this only after their [REDACTED] had their shot.
5. That [REDACTED] *postal service* [REDACTED] may be contacted on this due to the previous [REDACTED] bag of bones, and [REDACTED] hono scene.


HANDLING:
